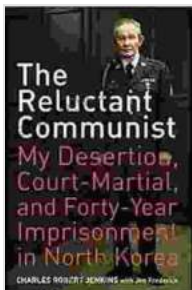


My Desertion Court Martial And Forty Year Imprisonment In North Korea

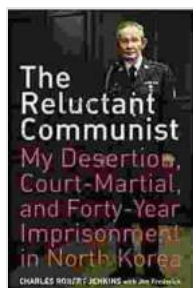

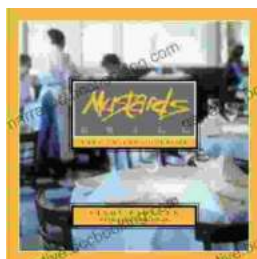
